- 4. Without prejudice to the other provisions, the rights referred to herein shall be non transferable to any other entity. The IMAGE DATASET shall not be transferred to or accessed from any other site.
- 5. END-USER acquires no ownership, rights or title in all or any parts of the IMAGE DATASET.
- 6. END-USER may not publish images from the IMAGE DATASET in any form (electronic or paper), except for those images which are explicitly indicated as being COPYRIGHT-FREE.
- 7. LTUTECH accepts no responsibility for the accuracy or completeness of the data or for the consequences of their use. LTUTECH gives no warranty for merchantability and/or fitness for a particular purpose of the IMAGE DATASET.
- 8. END-USER shall give appropriate references to LTUTECH in scholarly literature when the IMAGE DATASET is mentioned. In particular, END-USER shall provide a link to LTUTECH's website: http://www.LTUtech.com

- 15. This Agreement is subject to, construed and interpreted in accordance with the Law of France. Should it not be possible to settle amicably differences of interpretation out of this Agreement, then the case shall be brought before the regular courts of law for a decision. The "Tribunal de Commerce de Paris" shall be the only competent court. This AGREEMENT may be terminated by LTUTECH if END-USER breaches any material term or provision of this AGREEMENT. In the event that one of these articles is considered by French law or a French court decision as null, this invalid or illegal article shall not affect validity, legality and enforceability of the remaining provisions.
